The January 1, 1971 inventory estimates of livestock and poultry on U. S. farms and ranches show more cattle and calves, hogs and pigs, chickens and turkeys, but fewer sheep and lambs than a year earlier. Cattle and calves on farms and ranches on January 1, 1971 totaled 114.6 million, up 2 percent from the 112.3 million on hand a year earlier. Cows and heifers that have calved were up 2 percent with beef cows up 3 percent, but milk cows were down 1 percent. The 19.6 million sheep and lambs on farms and ranches January 1 are 4 percent less than a year earlier, continuing a decline in numbers which began in 1961. Stock sheep numbers were down 3 percent, and sheep and lambs on feed 9 percent, from a year earlier. The January 1, 1971 inventory shows the number of chickens on farms and ranches at 442.8 million, 2 percent above a year earlier, and turkeys at 7.5 million, up 10 percent. The number of hogs and pigs on farms December 1, 1970 were up 19 percent from a year earlier and totaled 67.5 million.

The value of all livestock and poultry on farms and ranches totaled a record high \$23.8 billion, 1 percent above the \$23.5 billion a year earlier. Meat animals (cattle, hogs and sheep) accounted for \$23.2 billion, compared with \$22.9 billion a year earlier. The inventory value of cattle and calves on January 1, 1971 totaled \$21.1 billion, up 5 percent from a year earlier. The sheep and lamb inventory as of January 1, 1971 was valued at \$462.9 million, down 9 percent from a year earlier. The inventory value of chickens was estimated at \$537.4 million, down 8 percent from a year earlier, but turkeys were valued at \$39.6 million, up 6 percent.

The value of the hog and pig inventory on December 1, 1970 is estimated at \$1.6 billion, a decline of 29 percent from the previous December 1 value.

CATTLE: The number of all cattle and calves on U. S. farms and ranches January 1, 1971 is estimated at 114,568,000 head, up 2 percent from the 112,303,000 head on January 1, 1970. The revised January 1, 1970 estimate is 27,000 below the preliminary estimate.

In Texas, the Nation's leading cattle State, the inventory was 12,578,000, up 3 percent from a year earlier. Iowa, second ranking cattle State, had 7,403,000, down 1 percent. In Kansas, the number increased 10 percent, the greatest percentage increase in the Nation.

The inventory was down 1 percent in the North Atlantic region, but increased in all others. The East North Central increased 1 percent; South Central and West, 2 percent; and the West North Central and South Atlantic, 3 percent.

On January 1, 1971, the number of all cows and heifers that have calved totaled 50,002,000, a 2-percent gain from the 48,982,000 head inventory a year earlier. Beef cow numbers increased 3 percent to 37,557,000, but this was partly offset by a 1-percent decline in milk cows -- down to 12,445,000. Beef replacement heifers, 500 pounds and over, increased 4 percent to 6,472,000, but milk cow replacement heifers of 500 pounds and over, decreased 1 percent to 3,939,000. Bulls, 500 pounds and over, advanced 3 percent to 2,306,000. Milk cows and milk cow replacement heifers, 500 pounds and over, totaled 16,384,000, 1 percent below a year earlier.

Other heifers, 500 pounds and over, numbered virtually the same as a year earlier, at 6,045,000. Included were 2,698,000 heifers weighing 500 pounds and over in feedlots in the 39 cattle feeding States on January 1, 1971. Steers, 500 pounds and over, totaled 15,404,000, up 2 percent from a year earlier. This total included 8,008,000 steers on feed as of January 1, 1971 in the 39 cattle on feed States. The number of all heifers, steers and bull calves under 500 pounds, was up 2 percent to 30,400,000, with the number on feed in the 39 States on January 1, 1971 being 1,991,000 head.

Imports of cattle and calves, mostly from Canada and Mexico, totaled 1,167,662 in 1970, up 12 percent from the 1,041,909 head imported during 1969.

The value of cattle and calves on farms and ranches January 1, 1971 amounted to \$21.1 billion, a 5-percent gain from a year earlier and the record high. The average value per head increased \$5, to \$185.

HOGS: There were 67.5 million head of all hogs and pigs on farms and ranches December 1, 1970 -- 19 percent more than a year earlier.

The value of all hogs and pigs on farms December 1, 1970 totaled \$1,579 million, 29 percent below the value last year, because of a lower average value per head which declined from \$39.00 on December 1, 1969 to \$23.40 on December 1, 1970.

SHEEP: Stock sheep numbers continued to decline during 1970 and on January 1, 1971 there were 16,937,000 on hand. The inventory was down 3 percent from a year earlier and 8 percent below the number on farms and ranches two years ago.

All classes of stock sheep declined last year. Ewes 1 year old and older on January 1, 1971 totaled 13,594,000 -- a drop of 2 percent from a year earlier. Rams numbered 512,000 -- down 3 percent. Wethers 1 year old and older were off 2 percent to 90,000 head. The total of ewe lambs, at 2,275,000 was 5 percent below a year ago. Wether and ram lambs decreased 2 percent and numbered 466,000.

On January 1, 1971, the 26 principal sheep feeding States had 2,623,000 sheep and lambs on feed for slaughter market, 9 percent less than a year earlier. Stock sheep plus sheep and lambs on feed totaled 19,560,000 compared with 20,288,000 last year and 21,238,000 on January 1, 1969.

The number of stock sheep and lambs on January 1, 1971, in the 35 Native States was 4,293,000 -- down 6 points from a year earlier. The number of ewes 1 year old and older in these States dropped 206,000 or 6 percent.

Numbers in the 11 Western States plus Texas and South Dakota totaled 12,617,000 head, 2 percent less stock sheep than on January 1 a year ago and 7 percent below the January 1, 1969 inventory. Sheep numbers declined or remained unchanged in all of these States except Texas -- up 3 percent, Arizona -- up 1 percent and Washington -- up 1 percent. Ewes 1 year old and older on January 1, 1971 totaled 10,120,000 in these 13 States, down 1 percent from a year ago.

On January 1, 1971 stock sheep and lambs were valued at \$398 million-- \$33 million less than last year, and \$6 million below 2 years ago. A lower value per head and a 3-percent decrease in inventory explain the drop in total value from a year earlier. The average value per head was \$23.50, compared with \$24.70 last year and \$22.00 on January 1, 1969.

GOATS: The number of goats and kids on Texas farms and ranches on January 1, 1971 was 2,058,000 head -- 20 percent less than a year ago and 36 percent below 2 years earlier. Total value of goats at \$11,731,000 was \$7,302,000 less than on January 1, 1970 and \$10,453,000 less than 2 years earlier. The average value per head was \$5.70, compared with \$7.40 a year earlier and \$6.90 2 years earlier.

CHICKENS: The number of chickens on farms January 1, 1971 (excluding commercial broilers) totaled 442,783,000, up 2 percent from January 1, 1970. Hens and pullets of laying age totaled 335,079,000, up 3 percent from a year earlier. The number of layers increased in the northern and western States, but declined in the southern States. Regional gains were: Western, 8 percent; West North Central, 7 percent; East North Central, 5 percent; and North Atlantic, 1 percent. The South Atlantic and South Central regions both showed a 1 percent decline. Hens 1 year old and older on farms January 1, at 135,314,000, were down 3 percent from the previous year and reflect the heavy culling of layers during the latter months of 1970.

The number of pullets 3 months old and older not of laying age totaled 47,384,000, down 3 percent from a year earlier due to the relatively light hatch in August 1970. Pullets under 3 months old totaled 53,328,000 -- 4 percent more than a year earlier. Other chickens at 6,992,000 were 4 percent above a year earlier.

The value of chickens (excluding commercial broilers) on farms January 1, 1971 was \$537 million compared with \$584 million a year earlier, and \$1.20 each compared with \$1.35 a year earlier.

TURKEYS: The number of turkeys (excluding market turkeys less than 4 months old) on farms January 1, 1971 totaled 7,462,000 birds, 10 percent more than a year earlier and 13 percent above 1969.

Turkey breeder hens totaled 3,437,000, up 1 percent from the 3,398,000 on hand a year earlier. The number of breeder hens on January 1 consisted of 3,029,000 heavy breeds and 408,000 light breeds. The number of light breed hens was up 11 percent from a year earlier, and the number of heavy breed hens was about the same.

Heavy breed turkeys tested for pullorum disease July through December 1970 were 12 percent above a year earlier. Light breed testings for the same period were up 3 percent. The number of all turkeys tested July through December, less those young banded breeders slaughtered during July-December, advanced 2 percent. In early January, growers intended to raise 1 percent fewer turkeys than in 1970. Intentions to grow turkeys were 1 percent less for heavy breeds and about the same number of light breeds as a year earlier.

The January 1, 1971 value of turkeys on farms (excluding market turkeys less than 4 months old) totaled \$39.6 million compared with \$37.2 million a year earlier. The average value per bird was \$5.30 compared with \$5.50 on January 1, 1970.
