Negotiated cash trading in the Western Cornbelt has been limited on light demand with a few live purchases at 124.00, however not enough for a full market trend. The latest established live market in the Western Cornbelt was last week from 120.00-124.00 and the latest established dressed market was on Thursday at 196.00. Negotiated cash trading in the Southern Plains has been mostly inactive on very light demand. Not enough purchases for a full market trend. The latest established live market was on Thursday at 120.00.
