



**Afternoon National Slaughter Cattle Review as of 2:00 pm Tuesday**

Thus far for Tuesday in Kansas negotiated cash trading has been limited on light demand. A few live purchases moved at 100.00. In the Texas Panhandle and Western Cornbelt negotiated cash trading has been inactive on very light demand. However, not enough for a market trend in any of these regions. Last week in the Southern Plains live purchases moved at 97.00. Last week in the Western Cornbelt live and dressed purchases moved from 100.00 to 102.00 and 160.00, respectively. So far for Tuesday in the Northern Plains negotiated cash trading has been at a standstill. For the prior week in Nebraska live and dressed purchases moved at 100.00 and 160.00, respectively. For the previous week in Colorado live purchases moved from 98.00 to 100.00.
