



**Afternoon National Slaughter Cattle Review as of 2:00 pm Wednesday**

So far for Wednesday negotiated cash trading in the Southern Plains has been moderate with moderate demand. Compared to last week live purchases traded 1.00 higher at 111.00. In Nebraska and the Western Cornbelt negotiated cash trading has been slow on moderate demand. In Nebraska, when compared to last week, dressed purchases traded 2.00 higher at 174.00. A few live purchases traded steady at 110.00 when compared to last week. In the Western Cornbelt live purchases moved steady to 1.00 higher at 110.00 and dressed purchases traded 2.00 higher at 174.00 when compared to the last market on Tuesday.
