
#### National Broiler Market-At-A-Glance


Whole broiler/fryer prices are trending steady to weak in regards to all sizes. Offerings are light to moderate with slight increases in the eastern region. Demand into all channels is mostly light to moderate. Floor stocks are sufficient entering the weekend. Market activity is mainly slow; with slight increases in the western region from slow to moderate. In the parts structure, white meat an thigh meat are mostly weak and the remainder of parts are steady at best. Offerings are light to moderate in the central region; mostly moderate in all other regions. Market activity is slow to moderate. In production areas, live supplies are desirable.

# Broiler-Type Eggs Set in the United States Up 1 Percent

Hatcheries in the United States weekly program set 233 million eggs in incubators during the week ending July 20, 2019, up 1 percent from a year ago. Average hatchability for chicks hatched during the week in the United States was 82.8 percent. Average hatchability is calculated by dividing chicks hatched during the week by eggs set three weeks earlier.

# Broiler-Type Chicks Placed in the United States Down Slightly

Broiler growers in the United States weekly program placed 185 million chicks for meat production during the week ending July 20, 2019, down slightly from a year ago. Cumulative placements from the week ending January 5, 2019 through July 20, 2019 for the United States were 5.40 billion. Cumulative placements were up 1 percent from the same period a year earlier.

Based on the preliminary chick placements, the number of fryers available for marketing during the week ending 31-Aug-19 is estimated at 165.3 million head. This compares to 165.5 million head the previous week and to 169.1 million head the same week a year ago, when the slaughter was 168.2 million head and the national weighted average price was 104.37 cents per pound.
