
National Broiler Market-at-a-Glance


Whole broiler/fryer prices are steady with mixed undertones for all sizes. Offerings are light to moderate in the Western region and moderate to instances heavy in all other regions. Retail and food service demand is light to mostly moderate with improvement noted for the upcoming weekend. Floor stocks are balanced to instances heavier then desired. Market activity is slow to moderate. In the parts structure, the market on boneless skinless breasts is mostly steady while bone-in breasts, tenderloins and whole wings are steady to weak. The market on dark items is steady to weak with limited export interest affecting movement for leg quarters and legs. Offerings of cut wings are light to moderate, while other white and dark meat items are moderate to heavy. Market activity for parts is slow to moderate. In production areas, live supplies are moderate at mostly desirable weights.

Broiler Hatchery

Broiler-Type Eggs Set in the United States Up 1 Percent

Hatcheries in the United States weekly program set 220 million eggs in incubators during the week ending October 12, 2019, up 1 percent from a year ago. Average hatchability for chicks hatched during the week in the United States was 82.3 percent. Average hatchability is calculated by dividing chicks hatched during the week by eggs set three weeks earlier.

Broiler-Type Chicks Placed in the United States Up 3 Percent

Broiler growers in the United States weekly program placed 182 million chicks for meat production during the week ending October 12, 2019, up 3 percent from a year ago. Cumulative placements from the week ending January 5, 2019 through October 12, 2019 for the United States were 7.64 billion. Cumulative placements were up 2 percent from the same period a year earlier.

Weekly Fryers Available for Marketing

Based on the preliminary chick placements, the number of fryers available for marketing during the week ending 23-Nov-19 is estimated at 158.4 million head. This compares to 159.5 million head the previous week and to 166.0 million head the same week a year ago, when the slaughter was 169.9 million head and the national weighted average price was 84.00 cents per pound.
