

IRISH POTATOES
Utilization of 1966 Crop with Comparisons

Movement of potatoes for fresh market from the 1966 crop totaled 133.9 million hundredweight--4 percent below the 1965 crop movement but 3 percent above 1964, according to the Crop Reporting Board. The quantity processed for food products (excluding starch and flour) continues to rise--66.4 million from the 1964 crop, 92.1 million in 1965, and 95.6 from the 1966 crop. Movement to starch and flour, at 11.0 million hundredweight, was much above the 8.1 from the 1965 crop.

Total sales from the 1966 crop accounted for 265.0 million hundredweight, only 1 percent above the 262.4 million from the crop a year earlier. This slight increase occurred in spite of the record large production harvested in 1966--306.9 million against 291.2 million a year earlier. The relatively large shrinkage and losses on farms from the 1966 crop--28.5 million compared to 17.4 million from the 1965 and 10.3 million hundredweight from the 1964 crop--account for most of the reduction in sales from the 1966 crop. Potatoes used on farms where grown for food continues to decline while seed used and volume fed to livestock on farms where grown are slightly above the crop of a year earlier.

The volume of potatoes used for frozen french fries continues to rise--34.0 million hundredweight for the 1966 crop against 32.3 a year earlier. Other frozen products also showed a gain for the 1966 crop compared with a year earlier. The 32.7 million hundredweight of potatoes used for chips and shoestrings continued to show an increase over the previous year's use of 31.3 million.

Dehydrated products (flakes, granules, diced, shreds, etc.) took 19.8 million hundredweight from the 1966 crop, a slight reduction from the 20.2 million used from the 1965 crop but much above the 10.8 million from the 1964 crop. Canned products, including hash, stew, soups, used 3.4 million, slightly above the 3.3 million used for the 1965 crop.

In line with the larger quantities used by starch and flour plants, the volume of potatoes sold for livestock feed, at 8.4 million, also was above the volume used from the 1965 crop.

On a fiscal year basis (July 1, 1966 through June 30, 1967) the quantity used for chips and shoestrings was 32.8 million hundredweight, which was above the 31.7 million used a year earlier and 28.8 million for the year ended June 30, 1965.
