SUGAR MARKET HIGHLIGHTS

DELIVERIES

Sugar distribution for continental consumption for calendar year 1984 totaled, 8.4 million short tons, raw value, down 5 percent from a year ago. Sugar exports for calendar year 1984 were 429,053 short tons, raw value.

INVENTORIES

Sugar stocks held by U.S. primary distributors on December 31, 1984, totaled 3.0 million short tons, raw value, up 21 percent from December 31, 1983.

DOMESTIC PRODUCTION

Sugar production for the mainland United States for calendar year 1984 totaled 4.1 million short tons, raw value, down 11 percent from the same period a year ago.

Hawaiian sugar production for calendar year 1984 totaled 1,063,526 tons, up 2 percent from the same period a year ago.

IMPORTS

Receipts of raw imported sugar by U.S. cane refiners for calendar year 1984 totaled 3.5 million short tons, raw value, up 13 percent from calendar year 1983. The Dominican Republic with 671,499 tons and the Philippines with 451,409 tons accounted for the largest and second largest tonnages.
