## **National Turkey Market At-A-Glance**

Domestic Market Highlights The market on frozen 8-16 lb. hens and 16-24lb. toms is steady to firm. Demand light to moderate. Fresh inquiry for November shipments light to moderate. Processor offerings of frozen Grade A 8-16 lb. hens and 16-24 lb. toms very light to moderate with 8-12 lb. hens the least available. Frozen Grade A basted equivalent processor offering prices on a national basis for 8-16 lb. hens are 86.00-95.00 cents FOB and 16-24 lb. toms 86.00-95.00 cents FOB for current deliveries. No trading reported.


The market on tenderloins and fresh tom breast meat steady, frozen tom breast meat steady to weak. The market on white trims is steady to firm. The market on 4-8 lb. breasts is generally steady. Demand light to moderate. Offerings of frozen tom breast meat moderate to moderately heavy, balance of white meat and white trims light to moderate. Further processed demand moderate to good. The market on institutional sized bone-in breasts are steady to instances firm with some not seeing the strength others are. Demand and offerings light to moderate. The tom bulk parts markets are steady to weak, mostly steady. The market on hen 2-joint wings is steady to instances firm with a few finding small sized product short of needs with the balance of hen parts mostly steady. Demand light to moderate, instances good. Offerings mixed, mostly moderate. The thigh meat market is steady with mixed undertones. Demand and offerings light to moderate. The mechanically separated turkey (MST) market is generally steady with fresh strongest. Demand and offerings light to moderate. Trading slow to moderate with fresh MST the most active.

Export Market Highlights Trading slow with activity reported on fresh thigh meat. The market on tom bulk parts is steady to weak, mostly steady with the balance of items generally steady. Demand and offerings light to moderate.
