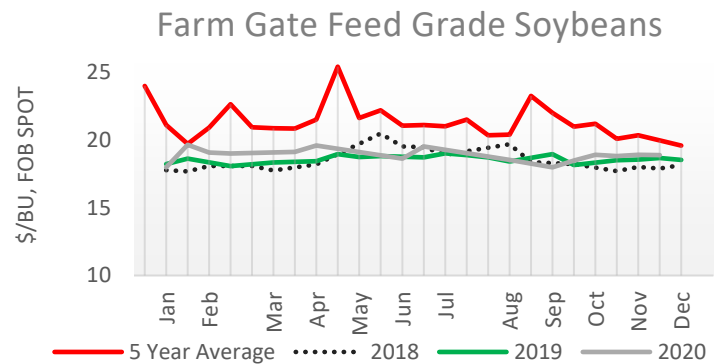
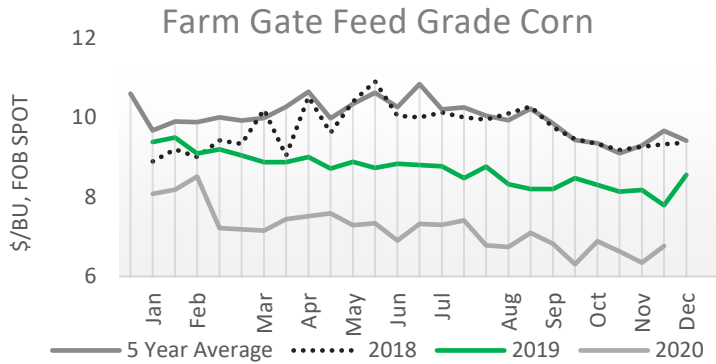

Current National Drought Summary (November 24, 2020)

Several Pacific weather systems, in the form of shortwave troughs, moved in the jet stream flow across the contiguous U.S. (CONUS) during this U.S. Drought Monitor (USDM) week. The weather systems brought rain or snow to parts of northern California and the Pacific Northwest, western Colorado, the northern Plains to Mid-Mississippi Valley, and Tennessee Valley to Northeast. Rain also fell across parts of Florida. The rest of the CONUS had little to no precipitation. Even where the precipitation fell, it was mostly below normal for the week. Areas receiving above-normal precipitation included parts of the Sierra Nevada, southern Idaho, other scattered parts of the Pacific Northwest, strips across the central Palins to Ohio Valley and across New England, and parts of Hawaii. Improvement in drought conditions occurred where precipitation was above normal, while drought expanded or intensified in some areas where dryness continued. Temperatures were largely warmer than normal across the CONUS, with anomalies 9 degrees F or warmer from the Southwest to northern Plains. Parts of the Pacific Northwest and East Coast were near to cooler than normal.
