About 729,323,000 broiler chicks were placed in 1954 in 13 important commercial broiler areas covered by weekly chick placement reports, the Crop Reporting Board announced. Placements varied from a high of 16,129,000 during the week ending March 27 to a low of 8,759,000 during the week ending December 25. The number of broiler chicks placed in the 13 areas was 5 percent above placements in 1953. Weekly placements were above the corresponding weeks in 1953 throughout most of the year. Only during the weeks ending May 29, June 5 and the last 11 weeks of 1954 were placements below those of 1953. In the 13 areas, Georgia led with 149,932,000 chicks placed, followed by Delmarva with 134,740,000, Texas with 73,282,000, North Carolina with 57,627,000, California with 54,698,000 and Alabama with 50,931,000 placements.

During 1954 the weekly reports were expanded from an area to a State basis in Delaware, Maryland, Virginia, West Virginia, North Carolina and Arkansas. Reports on weekly chick placements were inaugurated for the first time in October 1954 in Pennsylvania, South Carolina, Louisiana, Illinois, Missouri and Washington. Although complete totals for 1954 are available for only 13 areas at the present time, 22 States are included in the weekly chick placement report.

Rations fed in 1954 showed only minor changes in composition from those fed a year earlier. Corn and small grains accounted for about four-fifths of the total fed in both the East and West North Central areas, about 40 percent in the southern regions, about one-third in the North Atlantic, and one-fourth in the West. Commercial mixed feed made up well over half of the grain and concentrate rations fed in the North Atlantic and Western regions, about 40 percent in the South Atlantic and South Central areas and around 10 percent in the other regions. For data on kinds of feeds fed by States, see table 8.

Of the total grain and concentrate rations fed to milk cows in 1954, 51.1 percent was grown on the farms where fed. This compares with 50.8 percent in 1953 and 50.6 percent in 1952. Regionally, homegrown feeds were most important in the heavy grain producing areas, accounting for 75 percent of the total concentrate rations fed in the East North Central States and 71 percent in the West North Central region. In other areas, homegrown feeds represented 32 percent of the concentrate rations fed by dairy reporters in the South Atlantic and South Central regions, 27 percent in the North Atlantic, and 17 percent in the West. By States, the percentage of concentrate ration homegrown varied from 1 percent or less in California and most New England States to 80 percent or more in Michigan, Minnesota, Iowa, North Dakota, South Dakota, and Nebraska. Of the major grain components used in dairy rations in 1954, about seven-eights of the corn and oats was homegrown and about three-fourths of the barley. #### Concentrate Ration Values Lowest in Four Years

The average value per 100 pounds of grain and concentrates fed to milk cows in 1954 was \$3.30 -- 4 percent below 1953, 14 percent below the 1948 record high of \$3.84, but still the sixth highest annual average in over four decades of records. In each month of 1954, ration values were the lowest for the month since 1950. States showed the usual substantial variation in value of concentrate rations fed in 1954, ranging from \$1.98 per hundredweight in North Dakota to \$4.24 in Maine and West Virginia. The milk-feed price ratio for 1954 averaged 1.19, the lowest since 1947, 5 percent below 1953, and 6 percent below the longtime annual average. The butterfat-feed price ratio for 1954, which averaged 19.7, was the lowest for any year since 1934, 9 percent below 1953 and 16 percent below the 1933-52 average.
