



## Tree Nuts: World Markets and Trade

## **Pistachios**

Global production for 2019/20 is forecast down 11 percent to 694,000 metric tons (tons) as the United States and Turkey entered the off-year of the alternate bearing crop cycle, more than offsetting a sharp rebound in Iran. As a result of lower available supplies, world consumption, trade, and ending stocks are expected to decline.

**Iran's** production, reported by the Iranian Pistachio Association, is forecast to recover to 205,000 tons following last year's



weather shock that slashed output over 75 percent. Although shipments in the first few months of the marketing year have been slow, the pace is expected to accelerate to top markets China, the European Union, and Turkey, pushing total exports to 125,000 tons. Despite strong domestic consumption, ending stocks are forecast to jump to 25,000 tons following last year's reduced output and stocks drawdown.

**U.S.** production is forecast to decline 26 percent to 332,000 tons due to lower yields from the off-year. Please note that this forecast is based on shipment report data from the Administrative Committee for Pistachios. Prior years are based on data from the National Agricultural Statistics Service (NASS) as reported in the *Noncitrus Fruits and Nuts* report. With reduced output, exports are forecast to drop 28 percent to 200,000 tons on lower shipments to top markets China and European Union. Ending stocks are expected to fall to a 5-year low of just 35,000 tons.

**Turkey's** production is forecast to plunge 60 percent to 85,000 tons, similar to previous off-years. Lower production will have limited effect on trade as almost the entire harvest is consumed domestically.

China's imports are forecast to fall nearly 15 percent to 100,000 tons as shipments leading up to the Lunar New Year were not as strong as in previous years. About half of total imports occur during this period.

**EU** production is forecast up 7,000 tons to 18,000 on gains in Spain and Italy. With consumption seen nearly flat, imports are forecast down 6,000 tons to 95,000. The United States supplies a majority of the market, its second-largest after China.
