Catfish Processing up 21 Percent

Farm-raised catfish processed during September totaled 33.2 million pounds round weight, up 21 percent from September 1990.

Net pounds of processed fish sold during September totaled 16.7 million pounds, an increase of 9 percent from the comparable month in 1990. Sales of whole fish represented 31 percent of the total and fillets accounted for 48 percent. The remaining 21 percent were mostly steaks, nuggets, and value added products. Ice pack sales were 44 percent of the total amount sold.

The September average prices received by processors for whole fish were \$1.39 per pound for ice pack and \$1.59 for frozen fish.

Freshwater catfish imports during August totaled 621 thousand pounds, 83 percent of which were from Brazil. Imports were up 72 percent from the amount imported a year earlier. No exports were reported during August. Import and export data were compiled by the U.S. Bureau of the Census.
