CATFISH PROCESSING UP 18 PERCENT

Farm-raised catfish processed during November totaled 14.8 million pounds (6730 metric tons) round weight, according to the Crop Reporting Board, an increase of 18 percent from November 1984.

The November average price paid to growers was 70 cents per pound, 5 cents above November last year.

Net pounds of processed fish sold during November totaled 7.29 million pounds (3310 metric tons), an increase of 12 percent from the comparable month in 1984. Ice pack sales were 46 percent of the total amount sold.

The November average prices received by processors for whole fish were \$1.54 per pound for ice pack and \$1.68 for frozen fish.

Freshwater catfish imports during October totaled 96 thousand pounds (40 metric tons), 98 percent of which were from Brazil. Imports were substantially below the amount imported a year earlier. Import data were compiled by the U.S. Bureau of the Census.
