CATFISH PROCESSING UP 10 PERCENT

Farm-raised catfish processed during August totaled 31.1 million pounds round weight, up 10 percent from August 1989, according to the Agricultural Statistics Board.

The August average price paid to growers was 79 cents per pound, 11 cents above the same month last year.

Net pounds of processed fish sold during August totaled 16.3 million pounds, 13 percent above the comparable month in 1989. Sales of whole fish represented 31 percent of the total and fillets accounted for 48 percent. The remaining 21 percent were mostly steaks, nuggets, and value added products. Ice pack sales were 42 percent of the total amount sold.

The August average price received by processors for whole fish was \$1.63 per pound for ice pack and \$1.73 for frozen fish.

Freshwater catfish imports during July totaled 406 thousand pounds. Imports were down sharply from the amount imported a year earlier. Exports totaled zero during June and 1.50 thousand pounds to Angola during July. Import and export data were compiled by the U.S. Bureau of the Census.
