## Catfish Processing Up 17 Percent

Farm-raised catfish processed during June totaled 36.8 million pounds round weight, up 17 percent from June 1991.

Net pounds of processed fish sold during June totaled 18.9 million pounds, an increase of 18 percent from the comparable month in 1991. Sales of whole fish represented 33 percent of the total and fillets accounted for 48 percent. The remaining 19 percent were mostly steaks, nuggets, and value added products. Ice pack sales were 42 percent of the total amount sold.

The June average prices received by processors for whole fish were \$1.33 per pound for ice pack and \$1.58 for frozen fish.

Freshwater catfish imports during May totaled 392 thousand pounds, 69 percent of which were from Brazil. Imports were considerably above the previous year. Exports totaled 28.1 thousand pounds for May, all which were to the United Kingdom and Germany. Import and export data were compiled by the U.S. Bureau of the Census.
