## **Corn Stocks Up 4 Percent from December 2002 Soybean Stocks Down 20 Percent All Wheat Stocks Up 15 Percent**

**Corn** stocks in all positions on December 1, 2003 totaled 7.94 billion bushels, up 4 percent from December 1, 2002. Of the total stocks, 5.29 billion bushels are stored on farms, up 10 percent from a year earlier. Off-farm stocks, at 2.66 billion bushels, are down 6 percent from the previous year. The September - November 2003 indicated disappearance is 3.26 billion bushels, compared with 2.97 billion bushels during the same period last year.

**Soybeans** stored in all positions on December 1, 2003 totaled 1.69 billion bushels, down 20 percent from December 1, 2002. On-farm stocks totaled 820 million bushels, down 30 percent from a year ago. Off-farm stocks, at 866 million bushels, are down 8 percent from the previous year. Indicated disappearance for September - November 2003 totaled 910 million bushels, up 8 percent from the same period a year earlier.

**All wheat** stored in all positions on December 1, 2003 totaled 1.52 billion bushels, up 15 percent from a year ago. On-farm stocks are estimated at 492 million bushels, up 28 percent from last year. Off-farm stocks, at 1.03 billion bushels, are up 10 percent from a year ago. The indicated September - November 2003 disappearance is 518 million bushels, up 20 percent from the same period a year earlier.

**Durum wheat** stocks in all positions on December 1, 2003 totaled 67.0 million bushels, down 13 percent from a year ago. On-farm stocks, at 41.4 million bushels, are down 19 percent from last year. Off-farm stocks totaled 25.6 million bushels, down 1 percent from a year ago. The indicated September - November 2003 disappearance of 20.3 million bushels is up 26 percent from the same period a year earlier.

**Barley** stocks in all positions on December 1, 2003 totaled 198 million bushels, up 16 percent from December 1, 2002. On-farm stocks are estimated at 97.2 million bushels, 17 percent above a year ago. Off-farm stocks, at 101 million bushels, are 16 percent above December 2002. Indicated disappearance during the September - November 2003 quarter totaled 43.7 million bushels, down 19 percent from the same period a year earlier.

**Oats** stored in all positions on December 1, 2003 totaled 119 million bushels, 15 percent above the stocks on December 1, 2002. Of the total stocks on hand, 64.3 million bushels are stored on farms, 22 percent more than a year ago. Off-farm stocks totaled 54.9 million bushels, 7 percent above a year earlier. Indicated disappearance during September - November 2003 totaled 12.5 million bushels, up 58 percent from the same period a year ago.

**Grain sorghum** stored in all positions on December 1, 2003 totaled 234 million bushels, up 1 percent from a year ago. On-farm stocks, at 45.2 million bushels, are down 16 percent from last year. Off-farm stocks, at 189 million bushels, are up 6 percent from December 1, 2002. The September - November 2003 indicated disappearance from all positions is 221 million bushels, up 11 percent from the same period in 2002.


**Dry edible peas, lentils, and Austrian winter peas** stored in all positions on December 1, 2003 totaled 2,876 thousand cwt, 1,233 thousand cwt, and 53 thousand cwt, respectively. **Small, large, and all chickpeas (garbanzo beans)** stored in all positions on December 1, 2003 totaled 66 thousand cwt, 350 thousand cwt, and 416 thousand cwt, respectively. Small chickpeas are defined as peas that will pass through a 20/64 inch round hole screen. These estimates were initiated for administration of the 2002 Farm Bill which mandated a loan program for the pulse crops. Future stocks estimates of these crops will be made as of June 1 and December 1.

## On-Farm Grain Storage Capacity Down 1 Percent From Last Year

The United States on-farm storage capacity totaled 11.0 billion bushels on December 1, 2003, down 1 percent from December 1, 2002. Iowa continues to lead all States in on-farm storage capacity with 1.65 billion bushels, followed by Illinois and Minnesota with 1.20 billion bushels each; Nebraska, 960 million bushels; and North Dakota with 710 million bushels. The top five States account for 52 percent of the Nation's on-farm storage capacity. On-farm grain storage capacity includes all bins, cribs, sheds, and other structures normally used to store whole grains or oilseeds located on farms.

## Off-Farm Grain Storage Capacity and Facilities

Capacity of off-farm commercial grain storage totaled 8.50 billion bushels in the United States on December 1, 2003, down fractionally from December 1, 2002. Twenty-three States showed decreases from a year earlier and 12 States recorded increases in capacity. States showing the largest decreases include Iowa, 15.0 million bushels; Texas, 10.0 million bushels; California, 8.02 million bushels; Maryland, 6.10 million bushels; and North Dakota, 5.26 million bushels.

Illinois continued to lead all States in off-farm storage capacity, followed by Iowa, Kansas, Nebraska, and Texas. The top five States accounted for 52 percent of the Nation's off-farm storage capacity on December 1, 2003.

Off-farm grain storage capacity includes all elevators, warehouses, terminals, merchant mills, other storage, and oilseed crushers which store whole grains, soybeans, canola, flaxseed, mustard seed, safflower, sunflowers, rapeseed, Austrian winter peas, dry edible peas, lentils, and chickpeas/garbanzo beans. Capacity data exclude facilities used to store only rice or peanuts, oilseed crushers processing only cottonseed or peanuts, tobacco warehouses, seed warehouses, and storage facilities that handle only dry edible beans, other than chickpeas/garbanzo beans.

Off-farm storage facilities totaled 9,796 on December 1, 2003, up 3 percent from December 1, 2002. This increase was mainly a result of procedural changes in Iowa where each individual elevator location of multi-unit operations are being counted, but had not been in the past. States with the largest number of facilities are Illinois with 970; Iowa, 930; Kansas, 799; Minnesota, 605; and Nebraska with 508.

## Reliability of December 1, 2003 Grain Stocks Estimates

**Survey Procedures:** The grain stocks estimates in this report are based on surveys conducted during the first 2 weeks of December. Separate surveys are conducted to obtain the on-farm and off-farm estimates. The on-farm stocks survey is a probability survey that includes more than 60,000 operators selected from a list of producers that ensures all operations in the U.S. have a chance to be selected. These producers are asked to provide the total quantities of grain stored on their operations as of December 1, 2003. This includes all whole grains and oilseeds stored whether for feed, seed, or sale as well as any stored under a Government program.

The off-farm stocks survey is an enumeration of all known commercial grain storage facilities. This includes approximately 9,800 facilities with about 8.48 billion bushels of storage capacity. An effort is made to obtain a report from all facilities. Reports of stock holdings are normally received from operations covering about 90 percent of the capacity. Estimates are made for missing facilities to make the survey complete.

**Estimation Procedures:** On-farm and off-farm survey data are reviewed at the State and national levels for reasonableness, consistency with historical estimates, and current crop size. After estimates are made for on-farm and off-farm stocks, the totals of these two are combined and evaluated using the balance sheet approach. This method utilizes other sources of data to check the reasonableness of the stocks estimates. Estimates of production, imports, exports, crushings, milling, and all other recorded uses of grain and oilseeds are reviewed to make sure beginning stocks, production, utilization, and ending stocks are within reasonable balance and present the best possible estimate of stocks.

**Revision Policy:** On-farm and off-farm stocks are subject to revision the quarter following initial publication and again in the following December 1 "**Grain Stocks**" report published in January each year. Revisions can be made when late reports are received, errors are detected in reporting and calculations, and production estimates are revised. Estimates will also be reviewed following the 5-year Census of Agriculture. No revisions to these years will be made after that date.

**Reliability:** Reliability of the on-farm and off-farm stocks must be treated separately because the survey designs for the two surveys are drastically different. The on-farm stocks estimates are subject to sampling variability because all operations holding on-farm stocks are not included in the sample. This variability, as measured by the relative standard error at the U.S. level, is approximately 1.9 percent for corn, 2.4 percent for soybeans, and 2.0 percent for all wheat. This means that chances are approximately 95 out of 100 that survey estimates for stocks will be within plus or minus 3.8 percent for corn, 4.8 percent for soybeans, and 4.0 percent for all wheat of the value that could be developed by averaging the estimates produced from all possible samples selected from the same population and surveyed using the same procedures. The relative standard errors for sorghum, barley, and oats are 7.1, 4.3, and 4.6 percent, respectively.

Survey indications are also subject to non-sampling errors such as omission, duplication, imputation for missing data, and mistakes in reporting, recording, and processing the data. Off-farm, as well as on-farm stocks, are subject to these types of errors. These errors cannot be measured directly, but they are minimized through rigid quality controls in the data collection process and a careful review of all reported data for consistency and reasonableness.
