## GRAIN STOCKS BELOW YEAR AGO

Stocks of all grains on July 1, 1973 were below a year earlier, according to the Crop Reporting Board. Stocks of the four feed grains (corn, oats, barley, and sorghum) totaled 70.3 million tons, 14 percent less than July 1, 1972. April-June feed grain disappearance totaled a record high 48.9 million tons, 8 percent more than for the same quarter in 1972.

Stocks of all wheat were only half those of a year earlier, with durum supplies also down sharply. Soybean stocks were 23 percent below a year ago and flaxseed stocks were only one-fifth of the July 1, 1972 holdings.

Old crop carryover of all wheat on July 1, 1973 totaled 428 million bushels, 50 percent less than a year earlier, 42 percent less than 1971, and the lowest July 1 stocks since 1967. Off-farm holdings of 303 million bushels were 40 percent less than a year earlier and farm holdings, at 125 million, were only about one-third of a year earlier. Stocks in all positions on July 1 indicate disappearance during the July 1, 1972 to June 30, 1973 crop year at 1,980 million bushels, compared with 1,486 million a year earlier and 1,505 million 2 years ago. Disappearance for April-June 1973 was 499 million bushels, compared with 347 million a year earlier.

Old crop durum wheat stocks in all positions on July 1, 1973 totaled 36.7 million bushels, 47 percent less than a year earlier and 37 percent below 2 years ago. Farm holdings of 18.7 million were 61 percent below last year, and off-farm stocks of 18.0 million were down 15 percent. Disappearance during the crop year ended June 30, 1973 is indicated at 105.6 million bushels, compared with 81.0 million a year earlier.

As usual, estimates in this "Stocks of Grains" report include grain stored on farms and grain located at off-farm storage facilities but exclude grain in transit as of the survey date.

Old crop rye stocks in all positions on July 1, 1973 totaled 33.3 million bushels, 27 percent less than a year earlier but 19 percent more than July 1, 1971 stocks. Farm holdings of 6.8 million bushels were down 41 percent from a year earlier while off-farm stocks of 26.5 million declined 22 percent. Indicated disappearance during April-June was 15.6 million bushels, a more than fourfold increase from the 3.7 million for the same quarter a year earlier.

Corn in all storage positions on July 1, 1973 totaled 1,931 million bushels, 11 percent less than a year earlier but 23 percent more than July 1, 1971. Off-farm stocks of 564 million bushels were 3 percent less than a year earlier and farm holdings, at nearly 1,367 million bushels, were down 14 percent.

Indicated disappearance from all positions during April-June was 1,399 million bushels, compared with 1,208 million during the same quarter a year earlier.

Old crop oat stocks in all positions on July 1, 1973 totaled 414 million bushels, 24 percent below the record holdings a year earlier, and 20 percent less than 2 years ago. Holdings in off-farm positions, at 183 million bushels, were 10 percent less than a year ago and farm stocks, at 231 million bushels, were down 31 percent.

Disappearance during the April-June quarter was 172 million bushels, compared with 195 million during the same period of 1972.

Old crop barley stocks in storage on July 1, 1973 totaled 164 million bushels, 6 percent less than a year earlier but 6 percent more than July 1, 1971. Farm stocks, at 89 million bushels, were down 17 percent from a year ago while off-farm stocks, at 75 million bushels, were up 11 percent.

Disappearance from all storage positions during April-June 1973 was 100 million bushels, 9 percent less than the 109 million during the same quarter a year earlier.

Sorghum grain stored in all positions on July 1, 1973 totaled 201 million bushels, 27 percent less than a year earlier but 14 percent above July 1, 1971 holdings. Off-farm stocks were down 26 percent and accounted for more than three-fourths of total sorghum grain stocks. Sorghum holdings on farms were down 30 percent from last year. Indicated disappearance from all positions during the April-June quarter, at 165 million bushels, was 19 percent less than in the comparable quarter of 1972.

Soybeans in all storage positions on July 1, 1973, totaled 179.6 million bushels, 23 percent below last year's 232.8 million bushels and the lowest July 1 stocks since 1966. Farm stocks of 34.3 million bushels were 41 percent below last year's 58.4 million bushels, while off-farm stocks of 145.3 million bushels were down 17 percent from the 174.4 million bushels on hand a year ago.

July 1 stocks indicate a disappearance during September-June of 1,175 million bushels from a beginning supply of 1,355 million bushels. Disappearance during the same period a year earlier was 1,042 million bushels. During the past 10 months, approximately 630 million bushels of soybeans were processed for oil, around 457 million bushels were exported, and about 64 million bushels were used to seed the 1973 crop.

The April-June disappearance was 326 million bushels, 2 percent above the 319-million-bushel disappearance for the same period last year.

Old crop flaxseed holdings in all storage positions on July 1, 1973 totaled 3.7 million bushels, compared with 20 million last July 1 and 27 million on July 1, 1971. Off-farm stocks, at 3.3 million bushels, accounted for 89 percent of total holdings and were down from 17.6 million last July 1.

July 1 stocks indicated a disappearance of 30.4 million bushels for the year ended June 30 from a supply of 34 million bushels (carryover of 20.1 million bushels plus 1972 production of 13.9 million bushels). Crushings are estimated at 19.4 million bushels and exports at 8.8 million for the period from July 1, 1972 to June 30, 1973. About 1.0 million bushels were used to seed the 1973 crop.
